Registration Requirements

- Stallions must be registered ANNUALLY with the Virginia Breeders Fund
- To be eligible for awards from the Virginia Breeders Fund, a stallion owner/lessee must submit this application to the Virginia Thoroughbred Association prior to the commencement of the breeding season of the year in which the stallion will be siring Virginia-bred horses or within thirty (30) days of the stallion's entry into stud in the Commonwealth of Virginia if such entry is after the breeding season commences.
- A copy of the stallion's Jockey Club registration papers, clearly showing the front and transfer side of the document, must accompany this application.

I certify that this horse is eligible for Virginia Thoroughbred Stallion registration and participation in the Virginia Breeders Fund. I assume full responsibility for the registration of this horse, and agree that if the horse is later proved to be ineligible based on false or fraudulent information provided by me; 1) the horse shall no longer be considered a Virginia Thoroughbred Stallion; 2) I may be forever denied the privilege of participating in the Virginia Breeders Fund incentive programs; 3) any awards paid based upon the performance of an ineligible horse shall be returned in fully by the recipient to the Virginia Breeders Fund; 4) I am subject to any and all civil and criminal penalties associated with providing fraudulent information under the laws of the State of Virginia.
