Non winners of \$40,000 twice at a mile or over in 2018 allowed, 2 lbs.; \$40,000 once at a mile or over in 2018, 4 lbs.; \$30,000 once at a mile or over 2018, 6 lbs. (Maiden and Claiming races not considered in estimating allowances). Starters to be named through the entry box by the usual time of closing. Field will be limited to highest career earnings on the turf in 2017-2018. Failure to draw into the race cancels all fees. Trophy to the owner of the winner.
