ELIGIBILITY FOR REGISTRATION

- Stallions must be registered ANNUALLY with the Virginia Breeders Fund.
- To be eligible for awards from the Virginia Breeders Fund, a stallion owner/lessee must submit this application to the Virginia Thoroughbred Association prior to the commencement of the breeding season of the year in which the stallion will be siring Virginia-bred horses or within thirty (30) days of the stallion's entry into stud in the Commonwealth of Virginia if such entry is after the breeding season commences.
- All applications must be complete and accompanied by the appropriate registration fee or they will be returned. **Please make checks payable to and submit registration/application fees to: The Virginia Breeders Fund, 250 W Main Street, Suite 100, Charlottesville VA 22902.**

Affidavit: I, the undersigned, hereby certify that, pursuant to the information given by me above, this thoroughbred horse is a thoroughbred stallion that covers mares, other than test mares, only in Virginia during the breeding season in which it sires a Virginia-Bred Thoroughbred horse, or only during that part of the breeding season after entering Virginia. I certify that this horse is eligible for Virginia Thoroughbred Stallion registration and participation in the Virginia Breeders Fund. I assume full responsibility for the registration of this horse, and agree that if the horse is later proved to be ineligible based on false or fraudulent information provided by me; 1) the horse shall no longer be considered a Virginia Thoroughbred Stallion; 2) I may be forever denied the privilege of participating in the Virginia Breeders Fund incentive programs; 3) any awards paid based upon performance of an ineligible horse shall be returned in full by the recipient to the Virginia Breeders Fund; 4) I am subject to any and all civil and criminal penalties associated with providing fraudulent information under the laws of the State of Virginia.
