Report to be filed by owner/manager of participating facility. All facilities must be registered with the Virginia Thoroughbred Association before a Mare Residency Report can be processed. This form may also so be used to report a mare's arrival within 15 days of purchase at a sale.

If a resulting foal is reported eligible for Virginia-bred registration because of inaccurate, false or fraudulent information I provided, (1) the resulting foal will not be registered as a Virginia-bred, (2) I may be forever denied the privilege of registering Virginia-breds or participating in the Virginia-bred program in any way, (3) any award paid based upon the performance of an ineligible foal shall be returned to the Virginia Breeders Fund, (4) I will be subject to any and all civil and criminal penalties associated with providing fraudulent information under the laws of Virginia. I further agree to promptly provide any additional information requested by the Virginia Thoroughbred Association or Virginia Racing Commission.
